VFF USA believes in participatory monitoring and evaluation. The grant value was transferred to a partner organization - Rural Development Trust (RDT) that then distributes to local villages where the projects are implemented. The village community development committee reports to RDT. They perform monitoring and evaluation activities to ensure completion including providing photos, data collection, and guiding strategic decision making. RDT involves primary stakeholders as active participants ensuring inclusivity of women, people with disabilities, and other marginalized groups. The M&E process is lead by the community development committee to ensure that the perspectives and aspirations of those most directly affected are documented. RDT supports regular opportunities for feedback and documents early indications of progress or lack thereof in the achievements of the intended results.

**Projects Include:**

- Bikes for students: Attendance and performance data is collected monthly by high school principal and donors receive impact report within 12 months of project start date.
- Housing projects: Usually those projects need between 6 to 12 months to be completed. Donors receive an impact report at the end with the beneficiary profile and demographic details.
- Water purification system: Community assesses location, functionality and needed supports. Attendance at community meetings and water collection data is collected monthly for donor impact report.
- Scholarship for University students: Attendance and performance data is collected each semester. Donors receive impact report within 12 months of projects start date.
