VFF USA believes in participatory and transparent monitoring and evaluation (M&E) practices. All donations raised are transferred to our implementation partner in India, which manages project-related expenditures through a combination of centralized procurement and decentralized, community-led processes at the village level.

Expenditures are overseen by experienced personnel across different levels of project operations to ensure proper use of funds and full accountability. This includes procurement tracking, financial documentation, and submission of financial reports following project completion.

Monitoring and Evaluation activities are conducted at multiple levels. Sector leads oversee the project's implementation and are supported by a dedicated M&E team responsible for developing the monitoring framework and conducting regular impact assessments. These assessments help track progress against project goals and inform programmatic adjustments.

At the local level, community-based structures are actively involved in monitoring activities to ensure relevance, timely execution, and shared accountability. These teams contribute to the review of project milestones through data collection, documentation of progress, and narrative feedback.

In alignment with our donor commitments, VFF USA independently reviews project updates, verifies data quality with the implementing partner, assesses performance against agreed-upon indicators, and ensures budget compliance. These efforts support accurate and timely reporting to donors while safeguarding the confidentiality and dignity of all individuals reached through our programs.
